

NTS 940 Notes

Purpose:

The Notice to Ship is sent out from General Mills. It contains info for the trading partner on what they should ship on an interplant (Stock Transport Purchase Order) or customer order. We have this document available in 4010 or 4030* version of UCS. This transaction is sent to you when the shipment is connected to the delivery in our corporate system (event driven).

*Version 4030 is preferred because it contains additional information regarding order types and customer specific freshness parameters.

There are several documents attached to the shipment in General Mills SAP including:

- Shipment is in W0505 segment
- Delivery is in W0502 segment
- Order is in W0503 segment – If it is for an interplant order (between sites), it is the same as the delivery number. If it is for a customer shipment, it is the customer's PO number and is to be printed on the Bill of Lading.

Testing Notes:

List test scenarios to include....

Multiple deliveries on one shipment, if General Mills is planning your loads.

- Two deliveries 2086457843 and 2086457844
- They are to go on the same shipment 53273465
- Delivery 2086457844 is stop 1 of 2 (so should be on the back of the truck);
Delivery 2086457843 is stop 2 of 2 (loaded first)

Here is the key row of EDI data for both:

W05*N*2086457843*Test multi stop*002002*53273465~

W05*N*2086457844*Test multi stop2*001002*53273465~

A 945 would be sent back for each delivery – only thing unique is that they both reference the same shipment number in W0607 segment and proper link sequence for each in the W0608.

Regarding the Shelf Life Indicator (N9 segment in the detail with IQ and SHL qualifiers)

This is data that is only part of the 4030 map and used for refrigerated business.

This data is sent if a specific customer needs different freshness days. For example, our standard might be to ship a product with 20 selling days left. But a specific customer may request 22 or 25 days remain. In the example below, at least 10 days of shelf life will remain at time of delivery. If that cannot be fulfilled, use 7 days of variance in remaining shelf life to pick product.
